VOLUNTARY WAIVER AND RELEASE FROM LIABILITY

1. I am freely and voluntarily choosing to attend and participate in this event and to view and/or participate in activities that I know are adult-oriented and sexually explicit. I am aware that such activities involve acts of domination, submission, bondage, discipline, sadism and masochism, power exchange between willing and consenting adults, masturbation, sex or sexual acts, and other explicit and/or extreme sexual fetishes including, but not limited to: spanking, paddling, whipping, piercing, knife or edge or blood play, fire play, scat/urine play, humiliation, roleplay, suspension, fisting and other oral, vaginal and anal penetration. I realize that nudity or the demonstrations of, displays of, or images of acts considered "extreme" may occur. I agree to view these and assume the responsibility to remove myself from the room or facility should these exceed my personal limits. I understand that these activities involve certain risks and dangers, including the risk of serious injury or death. I voluntarily accept full responsibility for and agree to assume all risks involved.
2. I am aware that the use of the premises, facilities and equipment at this event may be dangerous and hazardous and I hereby assume all risk of the use of such premises, facilities and equipment. I agree to personally inspect all the premises, facilities and equipment and make my own independent judgment as to the use thereof. I agree not to rely upon the representations of anyone else in making such judgments.
3. I understand that this event is a private event open only to those who have been approved by The Portland Leather Alliance (PLA). I further understand and agree that any services I am acquiring from PLA are not necessary services; they are for my own personal use only, and are used for leisure activities only. I agree to abide by and follow all the posted safety and use instructions. I further understand that PLA and the premises owner are not responsible for any lost, damaged or stolen personal property.
4. As consideration for my being permitted to participate in and/or attend this event, I agree to hold harmless and indemnify PLA, the premises owner and other participants and their employees, agents, volunteers, officers, directors, contractors, members, and subsidiaries from any and all claims, including claims based upon negligence, arising out of my participation, in and/or attendance at this event or any activities associated with this event. This agreement is also binding upon my family members, heirs, and executors.
5. In the event of any litigation, dispute, or arbitration arising out of this agreement or my participation in and/or attendance at this event, I agree that the sole venue shall be litigation in Multnomah County, Oregon. Should any portion of this agreement be invalidated all remaining portions of this agreement shall remain in full force and effect.
6. I understand that no alcohol, marijuana, or any illegal recreational drugs or substances of any kind may be brought into the event. I understand that if I am noticeably affected by either alcohol or drugs, I will be denied admittance or asked to leave.
7. I understand that I will never solicit for prostitution nor consent to any form of payment for any acts done during a seminar, demonstration, meeting or gathering of any type sponsored by PLA and that I am aware that such solicitations and related activities are illegal under Oregon Prostitution and Solicitation Laws.
8. I agree that no audio/visual equipment, cameras or other recording devices (including cell phones and PDA devices) will be brought into any of the privately restricted areas (including the vendor areas, all seminars, demos and the dungeons). Any such equipment can be immediately confiscated and all recording data immediately destroyed. I further agree that any such equipment brought into events hosted by PLA in violation of the terms of this agreement shall immediately become the sole property of PLA and shall be retained in ownership by PLA from that time forward. All property confiscated from any violating member may also be retained permanently by PLA. Any member caught taking pictures with any device can be banned from further participation at PLA events forever.
9. I, the undersigned, have carefully read this document and fully understand its contents. I hereby certify that I am over 18 years of age, the name on my registration is my true and legal name, and that my signature below is my true legal name.
